1. APPLICANT must personally fill out completely and accurately the Application, including all financial data required. If information is incomplete or the information furnished cannot be verified, the Application will be denied.

 - G) An originally executed Electronic Funds Transfer ("EFT") Authorization; and
 - H) Confirmation of funds to invest (including a bank reference or copies of the last three (3) months bank statements).
3. APPLICANT must participate in an English & Math Test and interviews with various members of Pacific Convenience & Fuel, LLCs' management team.
4.
